## **DECLARATION SHELF LIFE POLICY**

King Nuts & Raaphorst distinguishes between bulk packages and consumer packages regarding the mentioning of the best before date.

## **Bulk packages:**

Due to the fact that mentioning of the shelf life on bulk packages is not mandatory King Nuts & Raaphorst uses a taste guarantee term after delivery. This term depends on the product group and can only be guaranteed if the transport- and storage conditions are met. These conditions can be found on the product specifications and are as follows:

## Storage and transport conditions:

The products must be preserved in a cool and dark environment which is free of odours, at a temperature between 15-18°C and a relative humidity about 65%, unless it is reported different on the package.

The products must be transported and stored under hygienic conditions, to ensure that the product cannot be contaminated by moulds, strange materials or smell.

It is possible that a best before date is mentioned on the bulk package. This date is the responsibility of the producer or packager in the country of origin.

Because, both inside and outside the specified shelf life term, food safety is not compromised, we limit ourselves to give a period starting after delivery of the product. This period should be seen as a taste quarantee and is separate from the food safety.

After expiry of the shelf life, organoleptic deviations may occur, for example: fat oxidation, crystallization, toughness, discoloration etc.

When micro-organisms are present on the product, they will not develop due to the fact that the Awvalue of the products is too low.

## **Consumer packages:**

According to the legislation for the labelling of consumer packages, shelf life dates are mentioned on the packages.
